Summary:

FOREST RIVER IS RECALLING CERTAIN MODEL YEAR 2012-2013 SHASTA REVERE RECREATIONAL VEHICLES. THE GROSS VEHICLE WEIGHT RATING (GVWR) AND CARGO CARRYING CAPACITY SPECIFICATION IS INCORRECT ON THE FEDERAL CERTIFICATION LABEL AND THE TIRE INFORMATION LABEL. THUS, THESE VEHICLES FAIL TO COMPLY WITH THE REQUIREMENTS OF PART 567, "CERTIFICATION."

Consequence:

INCORRECT WEIGHT INFORMATION MAY LEAD TO OVERLOADING, WHICH MAY CAUSE AXLE OR TIRE FAILURE, INCREASING THE RISK OF A CRASH.

Remedy:

FOREST RIVER WILL NOTIFY OWNERS, AND INCLUDE THE CORRECTED LABELS IN EACH LETTER. FOREST RIVER HAS NOT PROVIDED A NOTIFICATION SCHEDULE. OWNERS SHOULD CONTACT FOREST RIVER AT 909-873-3777.

Under 49 U.S.C. § 30112(a), it is illegal for anyone, including a manufacturer, distributor, dealer, or retailer to sell an item of equipment or vehicle that fails to comply with all applicable Federal motor vehicle safety standards.

We have received Forest River's proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.

Please be reminded of the following requirements:

You are required to provide an estimated date including month, day, and year, when you will send notifications to owners, dealers, and distributors as soon as it becomes available. Please be reminded that it is expected owners will be notified of a safety issue within 60 days of a manufacturer's notification to NHTSA of a safety defect.

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Since Forest River will be mailing the amended labels to the seven owners, if none of the owner notification letters/labels get returned to Forest River, please send us one quarterly status report stating a 100% completion rate.
