V13R OWNER NOTIFICATION LETTER (R12-001)

IMPORTANT SAFETY RECALL NOTICE

Dear Owner,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Campagna Motors has identified a potential safety concern with the V13R safety belt that relates to motor vehicle safety.

! IMPORTANT !

- Your V13R is being recalled.
- You should contact your nearest dealer or have a mechanic perform the attached procedure listed in the seat belt instructions sheet.

Why is a recall being conducted?

Your vehicle may have had an improper seat belt installation from the factory. This situation could affect the security of the passenger in case of frontal impact.

What are we doing about the problem?

If your vehicle is affected, the seat belt needs to be physically removed and reinstalled (see attached instructions). This procedure can be performed by an authorized Campagna Dealer or any local mechanic you may elect to use.
