**Re: Safety Notice Pertaining to All Kuryakyn Multi-Purpose Driver & Passenger Backrests
NHTSA Campaign no.: 13V-033**

Dear Kuryakyn Retailer,


This recall notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Kuryakyn Holdings, LLC (“Kuryakyn”) has decided that a potential safety concern which relates to motor vehicle safety exists with Kuryakyn Multi-Purpose Driver & Passenger Backrests (Kuryakyn part numbers 1660 and 1661). These backrests, sold between March, 2012, and May, 2013, have screws that attach the backrest to the motorcycle (via fender brackets also sold by Kuryakyn) and potentially could loosen during normal operation and potentially cause a fall or serious injury.

This photo below is of a chrome backrest that is involved (some affected models are black instead of chrome):



This photo below is of the affected screw (there are two screws affected, one on the left side and one on the right side):



You were previously advised to pull all these affected units from inventory and to insure they were not sold to

consumers. If you need retrofit kits to retrofit these unsold items please advise how many you will need (using the form on the last page of this letter), and we will ship them to you along with instructions on how to retrofit the unsold units.

As for those backrests that have already been sold to consumers and or installed on their bikes, we are asking retailers to send out a NHTSA approved letter to all those consumers for which you have contact information. This letter will be sent to you shortly and can be either emailed, faxed or sent US mail to your purchasers/customers. We expect that these letters will be sent out by your dealership within 3 days of receiving the consumer letter.

If you choose not to send these letters to consumers we will be glad to do it for you. All you need to do is fill out the last page of this letter with the consumer contact information so that we can mail the letters on your behalf. If you choose this option please send back the last page of this letter within 3 days of receiving this current letter.

You will soon be receiving the appropriate number of recall service kits and instructions for installation on customer's bikes that are affected by this recall. The number of kits will be based upon the attached form you return to us and upon our internal records which show the quantity that was shipped to your dealership. Kuryakyn will provide labor credits to have these service kits installed on consumer's bikes. Estimated time to install the service kit is 10 minutes.
