Problem Description:

Automobili Lamborghini America LLC (Lamborghini) is recalling certain model year 2006 through 2010 Murcielago Coupes and Roadsters fitted with carbon ceramic brake discs. The stainless steel screws that secure the brake rotors may fail after being exposed to due to salty conditions.

Consequence:

Failure of the securing screws may result in a reduction of braking ability, increasing the risk of a crash.

Remedy:

Lamborghini will notify owners, and dealers will replace the screws, free of charge. The safety recall is planned to begin by November 2013. Owners may contact Lamborghini at 1-866-681-6276. The manufacturer's numbers for this campaign are L82X-R.01.13 (Model Year 2006 Murcielago Coupe and Roadster), and LB82X-R.02.13 for the MY2007, 2008, 2009, and 2010 Murcielago Coupe and Roadster.

We have received Lamborghini's proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.

Please be reminded of the following requirements:


Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.

On August 20, 2013, NHTSA announced new changes to the requirements governing safety recalls. Some of these requirements are already in effect. Please ensure your company will be in compliance with each requirement on, or before, its respective effective date.
