

Pace American is responding to the letter of July 2, 2008 from George H. Person, Chief of the Recall Management Division. This notified us that there is an additional recall on certain Dometic refrigerators. Pace American has searched its records and cannot find any record that it has purchased any Dometic refrigerators except the one that we discussed in a copy of our letter of August 31, 2007. This was a refrigerator that we shipped to a dealer for installation in one of our trailers. A copy of the letter is attached. At that time, we were informed that since we did not install the refrigerator, but merely passed it through, that we had no further obligations concerning a recall.

If you or Dometic have any information that we have purchased more Dometic refrigerators than that one, please let us know and we will conduct another search. Thank you for your assistance.
