Subject: Safety Recall 08KWB – Brake Assembly Cracking

Dear Kenworth Customer,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Kenworth Truck Company has decided that a defect which relates to motor vehicle safety exists in 2004 through 2009 model year of certain T2000, T800, T600, W900 & T660 model trucks with wide-base tires, long-stroke brake chambers and Airglide 400 suspensions manufactured at Kenworth's Chillicothe and Renton plants between July 7, 2003 and September 11, 2008. Your vehicle has been identified as having been manufactured within this time period and may contain a defect.

Your configuration of vehicle may develop an increase in lateral and vertical rear axle movement. This movement may cause parts of the brake assembly (i.e. brake cam tube, brake chamber bracket, brake spider and brake chamber) to develop fatigue cracks, possibly resulting in reduced vehicle braking performance. This condition was determined by Kenworth to be a safety-related defect.

<i>The problem is...</i>	Cracked brake cam tube, brake chamber bracket, brake spider, brake chamber
<i>What your dealer will do...</i>	Inspect rear brake assemblies, replace damaged parts, and add brake camshaft tube support brackets on all rear axle wheel ends
<i>What you must do ...</i>	Contact your dealer immediately to schedule an appointment

Kenworth has initiated a recall to inspect your rear brake assemblies, replace damaged parts, and add brake cam tube support brackets. Please contact your Kenworth dealer immediately to schedule an appointment for this repair. To find your nearest Kenworth dealer, please visit Dealer Locator at www.Kenworth.com. This repair should take no more than 3-1/2 hours, and will be performed at no charge to you. If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.

If you require further information about this recall, reimbursement of a pre-notification remedy associated with this recall or experience any difficulty in making arrangements for this repair, please contact: Kenworth Truck Company, P.O.
