In accordance with the requirements of the National Traffic and Motor Vehicle Safety Act and the procedure described in 49 CFR 573.6, the fourth Quarterly Report is being furnished. **Updated information is noted in bold font.**

- 3) Populations as jointly identified by Kenworth & Caterpillar:
 - a) PI10641
 - i) Revised total (US and Canada) stands at 12,362.
 - ii) **Revised total (US only) decreased from 10,828 to 10,812. This is due to an additional 16 engines being reported as exports in the latest dataset.**

b) PI10645

i) Revised total (US and Canada) decreased from 18,971 to 18,970 due to two engines reported as scrapped (and one of those was previously reported as a replacement).

ii) Revised total (US only) decreased from 15,825 to 15,820 due to two engines reported as scrapped (and one of those was previously reported as a replacement) and four engines found to be in Canada.

c) PI10658

i) Total population (US and Canada) stands at 2,671.

ii) US population stands at 2,398.

d) Revised total (US only) for all three campaigns is now 29,030.

4) Completion percentages for each campaign now stand at:
