SUBJECT: 2,409 Saturn 2000 S-Series (SC, S^LW, and SW) vehicles manufactured from June through August 1999. These vehicles do not comply with requirements of FMVSS No. 208, "Occupant Crash Protection." Some of these vehicles were manufactured with welds in the instrument panel carrier assembly that do not meet Saturn quality standards. *GM Recall No. 99051/Saturn Recall No. 00-C-04.*

This is an initial acknowledgment for this recall. A formal acknowledgment letter will be forthcoming shortly. After our review of your report and associated documents, we may have additional comments or concerns.

Under 49 U.S.C. § 30112(a), it is illegal for anyone, including a manufacturer, distributor, dealer, or retailer to sell an item of equipment or vehicle which fails to comply with all applicable Federal motor vehicle safety standards.

We have reviewed your dealer/owner notification letter drafts and they do not meet the requirements of Part 577. Please remove the word "may" from the second paragraph, first sentence. "Saturn ...S-Series vehicles "may" fail to meet....".

As stated in Part 573.6, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. As stated in your report, owner notification is expected to occur during August 1999. Therefore, the first quarterly report will be due in this office by October 30, 1999.

We have reviewed General Motors Corporation's (GM) Noncompliance Information Report dated August 20, 1999, submitted in accordance with 49 CFR Part 573, "Defect and Noncompliance Reports." This recall involves 2,409 Saturn 2000 S-Series vehicles manufactured from June through August 1999. These vehicles do not comply with the requirements of Federal Motor Vehicle Safety Standards (FMVSS) No. 208, "Occupant Crash Protection." Some of these vehicles were manufactured with welds in the instrument panel carrier assembly that do not meet Saturn quality standards. The assigned identification number for this recall is 99V-230 (GM Recall No. 99051/Saturn Recall No. 00-C-04).


