This letter responds to the December 29, 2009 letter directing Newmar Corporation to provide information related to a September 6, 2007 recall announced by Keystone RV Company and a December 4, 2008 recall announced by Coachmen Recreational Vehicle Company, LLC; involving glass shower doors with towel bars manufactured by Irvine Shade & Door, Inc.

Newmar Corporation does purchase and install glass shower doors manufactured by Irvine Shade & Door, Inc. Although Keystone RV Company and Coachmen Recreational Vehicle Company, LLC have identified shower doors manufactured by Irvine Shade & Door, Inc. as components involved in specific recalls, Newmar does not have any data indicating these shower doors to be defective.
