SAFETY RECALL OF COMBINATION HEAD LIGHT/CLEAR CORNER, BUMPER & SIDE MARKER LIGHTS

To all Distributors of CK Motorsport Inc. who have purchased the above mention products from our company.

This notice is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

CK Motorsport has decided that all combination headlights, clear corner, bumper & side marker lights sold by us to you fail to conform to Federal Motor Vehicle Safety Standard No. 108. CK Motorsport is recalling all products purchased from CK Motorsport that is currently in our distribution channel. Please read and follow the instructions below.

Items covered by this recall

The part numbers of the combination lamps covered by this recall, and the associated vehicle models, are set out on the enclosed list.

SAFETY RISK RELATED TO THE PROBLEM

CK Motorsport has discovered that some of the combination lamps that it imported do not have an amber side reflex reflector, even though the original equipment lamps that they are designed to replace have such a reflector. The absence of an amber reflector can reduce the ability of other drivers to see a vehicle and could increase the likelihood of a crash.

Remedy action

CK Motorsport will honor all returns of the combination lamps identified on the enclosed list, and will refund the full purchase price that you paid for such lamps.

Steps you should do

If you still have any of the combination lamps covered by this notification in your possession, please contact CK Motorsport at the following number: 909-610-7211, you will be advised how to return your lamps for a full refund.

Please note that it is a violation of Federal Law to sell an item of motor vehicle equipment covered by this notification unless the noncompliance is remedied.

If you believe that CK Motorsport has failed to provide a free remedy within a reasonable amount of time, you may submit a complaint to the Administrator, National Highway Traffic Safety Administration, 400 Seventh Street, SW., Washington, DC 20590; or call the toll-free Vehicle Safety Hotline at 1-888-327-4236 (TTY: 1-800-424-9153); or go to <http://www.safercar.gov>.
