Dear Valued Customer:

This notice is being sent in compliance with the requirements of the National Highway Traffic Safety Administration. Your boat trailer has been included in a recall. You should discontinue use of your trailer immediately until the correct capacity tag has been applied.

It has been determined that your trailer may have an incorrect capacity tag that does not meet the National Highway Traffic Safety Administration's regulations. This letter is to inform you that the original capacity tag affixed to your 2006 Tracker Pro Team 160 trailer displays an incorrect weight capacity for the trailer. We are providing a new capacity tag to be affixed to your trailer. Please review this letter and follow the instructions that have been provided.

The original capacity tag should be located near the front of the trailer. The original capacity tag can be removed with a knife or scraper along with acetone or any petroleum based adhesive remover. After the original capacity tag is removed the surface must be washed with soap and water and allowed to dry completely before the new capacity tag is affixed. The new capacity tag should be affixed to your trailer by removing the protective paper strips on the back of the tag. The new capacity tag should be held in place until firmly affixed.

Your original boat package does not exceed the correct capacity limit listed on the new trailer tag. However, if you have made modifications to your boat package, you should seek the assistance of your dealer to confirm that the package weight is under the limit.

After you complete this process, please complete the enclosed acknowledgement form. Enclose the old capacity tag in the self addressed paid envelope and we will send you a \$20.00 Bass Pro Shop Gift Card for your cooperation.

**Bulletin Number:** TS-0010  
**Models Affected:** 2006 Tracker Pro Team 160 trailers manufactured prior to 4/25/06  
**Condition:** Incorrect trailer capacity tag

## Information

**DESCRIPTION OF CONCERN:**

Tracker Marine Group recently discovered that the 2006 Tracker Pro Team 160 trailer capacity tags are incorrect. Capacity tags on 2006 Tracker Pro Team 160 trailers manufactured prior to 4/25/06 have tags that show the maximum trailer capacity at 2200 pounds. The correct capacity tag should have the maximum trailer capacity at 1990 pounds.

**CORRECTIVE ACTION:**

Correct capacity tags are being sent to dealers with affected model trailers. Once the tags arrive, replace the capacity tag on all 2006 Tracker Pro Team 160 trailers at your dealership.

**CUSTOMER NOTIFICATION:**

All warranty registered trailer owners of the above mentioned model have been sent a correct capacity tag in the mail.
