This brief letter shall serve as a follow-up report (see Rexhall's 8/30/07 report) to NHTSA regarding the above listed recall.

Potentially affected vehicles: 6 or 8. On September 26, 2007 Rexhall Industries, Inc. received a product query from Dometic, which indicates potentially affected model #s, and invoice #s of product sold to Rexhall. Rexhall has determined overstated ranges of motorhomes (totaling 2,345) within which the said 6-8 refers may be installed, identified by Rexhall stock #s as follows:

them mailing recall notices. On 4/10/08 Rexhall mailed 100 sheets to Dometic's recall administration service Stericycle for the purpose of them mailing recall notices. Today, 4/15/08, Rexhall emailed the final 3 customers' and dealers' information to Dometic and Stericycle. That will conclude Rexhall's forwarding addresses of customers and dealers to Stericycle and Dometic.

Notification: Previously Dometic has repeatedly confirmed that they will notify all pertinent customers and dealers upon Rexhall providing the contact information. Rexhall has provided such. We anticipate Dometic accomplishing the notifications in a timely manner.

Previously, on 9/4/07, Mr. Ric Willard of NHTSA indicated that Dometic may in fact fulfill the six consecutive quarterly reports to NHTSA. Thus, Rexhall is unclear as to any further reporting obligation. Should any further reports or information be required, please inform me.
