Dear Sir or Madam,

The purpose of this letter is to make you aware of a potential safety problem in vehicles that you manufactured and to remind you of your responsibilities under Federal law.

The Office of Defects Investigation (ODI), Recall Management Division (RMD) is conducting a review of safety recall 08E-032. In a letter dated April 11, 2008, Dometic Corporation (Dometic) reported that certain two-door refrigerators contain a boiler tube that may fatigue and develop a crack. Should a cracked boiler tube release a concentrated amount of cooling liquid and an ignition source is present, a fire may occur. A fire can cause personal injury to vehicle occupants. NHTSA assigned recall number 08E-032 to this matter.

In Dometic's Defect Information Report, Adirondack Kabins LLC (your company) was identified as a purchaser of these units. A copy of Dometic's report is enclosed for your information.

Please Note: Your company might have been involved in a previous Dometic two-door refrigerator recall from August 2006 (NHTSA recall number 06E-076). This **new** recall serves as a follow-up to the previous recall and expands the serial number range for affected units. This new recall may require your attention and any similar means of action your company might have taken for the 2006 recall. Should your company have received these newer recalled units **and** installed them as original equipment in a motor vehicle; a new Defect Information Report will be required.

If your company received an information request letter from NHTSA regarding the 2006 Dometic 06E-076 recall and your company has not issued a response or filed a Defect Information Report with this office, please contact us immediately as civil penalties are currently being assessed per 49 U.S.C. §30165 for this failure to respond.

Pursuant to Federal law, manufacturers of motor vehicles sold, offered for sale, delivered, or imported into the United States must notify the National Highway Traffic Safety Administration (NHTSA) whenever they decide that a safety defect or a noncompliance with a Federal Motor Vehicle Safety Standard is identified in one of their vehicles. In the case of a defect or



noncompliance in original equipment installed in the vehicles of more than one manufacturer, notification to NHTSA must be made by the original equipment manufacturer as to the equipment item, and by each vehicle manufacturer as to those vehicles it manufactured in which the defective equipment was installed. The content of that notification is specified in 49 U.S.C. 573.6, Defect and Noncompliance Information Report. A detailed guide to safety recalls may be found at <http://www-odi.nhtsa.dot.gov/recalls/static/recompendium.pdf>. Sample forms may be found at <http://www-odi.nhtsa.dot.gov/recalls/forms/index.cfm>. As of the date of this letter, we have not received a report from your company.

This letter serves to remind you of your company's responsibilities, and to request that you supply the required report. In that report, please be sure to include an identification and description of your company's vehicle(s) that potentially contain the defective unit; a chronology of all principal events involving the determination that a safety related defect may exist in your company's vehicle(s), including related communications between your company and Dometic; and an identification of your company's role in the distribution chain for potentially affected refrigerators. Specifically, please include the date on which you received notification of this matter from Dometic.

If you primarily sell new vehicles or equipment for purposes other than resale, please identify yourself as a dealer. If you primarily sell new vehicles or equipment for resale, please identify yourself as a distributor. If you manufacture new motor vehicles, please identify yourself as a vehicle manufacturer. If you manufacture original equipment for new motor vehicles, please identify yourself as an original equipment manufacturer. If you manufacture motor vehicle equipment for resale, please identify yourself as a replacement equipment manufacturer. (For more detailed definitions please see 49 U.S.C. § 30102).

In view of the risk of fire and injury, and your company's obligations under Federal law, we are also reminding your company that it is required to issue timely notification to owners who may have purchased vehicles with the defective refrigerators. In advance of issuing its owner notification letters, your company must submit a draft of its letter to NHTSA for review. Your company is reminded that this letter must meet the requirements of 49 CFR 577.5, "Notification pursuant to a manufacturer's decision." Your company is further reminded that notifications must be sent to those persons registered under State law as the owners of the vehicles. If particular owners cannot be reasonably ascertained by State records, notifications must be sent to those persons you identify as the most recent purchasers. We are also reminding your company that it is required to notify dealers and distributors as required by 49 CFR 577.13.

In addition to the defect notification report and the draft owner notification letter, please also provide a proposed schedule for conducting the owner notification that includes the following information:

- a. the date on which the search of current state motor vehicle registration records will be initiated in order to update the original owner list;
- b. the approximate date on which the revised owner list will be available to initiate owner notification;
- c. the approximate date on which the owner notification will begin;
- d. the approximate date on which the owner notification will be completed (if the owner notification is to be staggered, give the beginning and ending owner notification date for each segment); and

e. the approximate date on which the dealer notification will be completed.

Please further note that you must file six quarterly recall status reports as required by 49 CFR 573.7. These reports are to be filed on consecutive yearly quarters beginning with the quarter in which notification to owners begins.

If your company does not agree with the decision made by Dometic that the equipment contains a safety defect, please provide an explanation for your company's position. If your company has not received any of this equipment, or if your products are not available to be sold, offered for sale, delivered, or imported into the United States, please so state. If your company resold any of the equipment other than in its products, please identify the purchaser by name and address.

This letter is being sent to your company pursuant to 49 U.S.C. § 30166, which authorizes NHTSA to conduct any investigation that may be necessary to enforce Chapter 301 of Title 49. Your company's failure to respond promptly and fully to this letter could subject your company to civil penalties pursuant to 49 U.S.C. § 30165 or lead to an action for injunctive relief pursuant to 49 U.S.C. § 30163.

If your company claims that any of the information or documents provided in response to this information request constitute confidential commercial material within the meaning of 5 U.S.C. § 552(b)(4), or are protected from disclosure pursuant to 18 U.S.C. § 1905, your company must submit supporting information together with the materials that are the subject of the confidentiality request, in accordance with 49 CFR Part 512, as amended (69 Fed. Reg. 21409 et seq; April 21, 2004), to the Office of Chief Counsel (NCC-111), National Highway Traffic Safety Administration, Room W41-227, 1200 New Jersey Avenue, S.E., Washington, D.C. 20590. Your Company is required to submit two copies of the documents containing allegedly confidential information (except only one copy of blueprints) and one copy of the documents from which information claimed to be confidential has been deleted. Please remember that the word "CONFIDENTIAL" must appear at the top of each page containing information claimed to be confidential, and the information must be clearly identified in accordance with 5 U.S.C. § 512.6.

Your company's written response must be submitted to this office within 10 days of receiving this letter. In your response, please be certain to include a reference to this matter's identification number which is **EQ08-010**.
