Trails West reviewed its purchasing records to determine when and how many of the defective battery separators were purchased. This part is only used in trailers that get a generator option or generator ready option. We used our manufacturing log to determine each individual trailer that included either option within the effective time frame. The beginning date was determined by including any trailer produced after the first separators were purchased. The final date was August 21st, 2012 which is when we received notice of the recall by NHTSA.
