VOLUNTARY SAFETY RECALL NOTICE

Introduction- Progressive Dynamics, Inc. is issuing a VOLUNTARY SAFETY RECALL NOTICE of all Models PD4560 and PD4590 power converters manufactured between January 14, 2013, and February 8, 2013 ("Risk Period"). The prefix to the Serial Numbers for these power converters is A13014 through A13039.

1. **A clear description of the defect or non-compliance-** The two A/C stab rails under the A/C breakers should be not less than 0.38" apart. There may be a separation of .038" on some, but not all, of the tabs. It is impossible to determine without examination, which units are defective and, therefore, all units manufactured during the Risk Period should be checked.
2. **An evaluation of the risk to motor vehicle safety reasonably related to the defect or non-compliance-** Less than 0.38" separation of the two A/C stab rails could create a short circuit which could lead to a fire.
3. **The measures to be taken to obtain a remedy of the defect or non-compliance-** Replacement stabs (811777) and screws (109256) will be sent to each Original Equipment Manufacturer, Dealer, Distributor or the owner at NO CHARGE, who requests a replacement. Please supply the serial number of the defective ALL IN ONE power converter and the make, model and VIN number of the Recreational Vehicle. The proper inspection and repair procedures, with pictures, is attached and is also available on our website www.progressivedyn.com
4. **A statement that manufacturer giving notice will remedy the defect or non-compliance without charge-** If a recipient of this notice chooses to check the power converters and make the repairs itself, it should contact Progressive Dynamics, Inc. to establish a means of reimbursement for the labor involved. Checking the units and supplying the necessary parts and labor to make the repairs will be done without charge to the recipients of this Notice.
5. **The earliest date on which the defect or non-compliance will be remedied without charge-** Stabs and screws are available for immediate shipment.
6. **Retail Purchaser/Consumer-** In the event a Model PD4560 or PD4590 power converter manufactured during the Risk Period has been sold to a Retail Purchaser/Consumer please notify Progressive Dynamics, Inc. as soon as possible supplying us with the name and address of the Retail Purchaser/Consumer.




PD4560 & PD4590 AC STAB CHECK




WARNING:

Make sure all power is disconnected before proceeding.


1. Remove screw securing cover to housing. Remove cover.




2. Remove screw securing main breaker hold down. Remove main breaker. (It is NOT necessary to disconnect the wires from the breaker before removing.)



3. With main breaker removed, verify that there is a minimum of 0.38" gap between the two stabs.
 - ✓ If gap is less than 0.38" or if there is no gap, proceed to step 4.
 - ✓ If gap is greater than 0.38", proceed to step 5.



4. Remove and discard BOTH stabs. Install new, PDI provided, stabs and secure with existing screws. Verify minimum 0.38" gap between the ends of the stabs.



5. Reinstall main breaker, main breaker hold down and cover.
6. Reconnect power


