On May 1st, New Heights LLC submitted an initial Defect And Noncompliance Report via email. Further information has been compiled and this is the revised report in its entirety.

New Heights LLC has been notified that a supplier, Carlisle Brake and Friction, has initiated a safety recall on a trailer brake actuator supplied to New Heights LLC by Nuera Transport and Redneck Trailer Supplies, which has been installed on some of our trailers. New Heights LLC has determined that a defect, which relates to motor vehicle safety, exists in an item of motor vehicle equipment listed below, and is furnishing notification to the National Highway Traffic Safety Administration in accordance with 49 CFR Part 573 Defect and Noncompliance Reports.

The manufacturer of the component to be recalled is Carlisle Brake and Friction, located at 6180 Cochran Road, Solon, OH 44139. Their Safety Recall Campaign Number is 12E-003.

III. Describe Defect or Noncompliance

Defect Description:

One of the rotating components in the hydraulic pump for the the actuator missed a heat treat operation. As a result, it is subject to wear at a higher than normal rate. As the component wears, the load on the electric motor that powers the unit increases until either the fuse that protects the motor fails or the motor itself fails. In either case, a loss of trailer braking may occur.

New Heights LLC was notified by NHTSA on April 22nd, 2013 via correspondence EQ12-003 that an official recall had been conducted by Carlisle Brake & Friction Company.
