NHTSA Recall 13V-246

IMPORTANT SAFETY RECALL NOTICE

Dear Acura RSX Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

What is the reason for this notice?

Acura has decided that a defect which relates to motor vehicle safety exists in certain 2006 model year RSX vehicles. There is potential for a vacuum leak within the brake booster which may cause a decrease in brake assist. A decrease in brake assist can increase the risk of a crash.

What should you do?

Call any authorized Acura dealer and make an appointment to have your vehicle's brake booster inspected and, if necessary, repaired **at no cost to you**. The complete process may take approximately 84 minutes; however, your vehicle will need to be at the dealer for a longer period of time. We recommend that you plan to leave your vehicle for half a day to allow the dealer flexibility in scheduling.

Who to contact if you experience problems.

If you believe that American Honda or the dealer has failed or is unable to remedy the defect in your vehicle, without charge, within a reasonable period of time (60 days from the date you first contact the dealer for a repair appointment), you may submit a complaint to:

What to do if you feel this notice is in error.

Registration records indicate that you are the current owner or lessee of a 2006 Acura RSX involved in this campaign. If this is not the case, or the name/address information is not correct, please complete and sign the Information Change Card and return it in the enclosed postage-paid envelope. We will then update our records.

What if you already had your vehicle repaired for this issue.

If you previously paid to have the brake booster replaced, you may be eligible for reimbursement. Refer to the attached Instructions for Reimbursement for the eligibility requirements and the reimbursement procedure.

Lessor Information.

Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within 10 days.
