Dear Ms. Lewis:

Hyundai Motor Company previously submitted a Defect Information Report to NHTSA on April 9, 2013 regarding a recall campaign of certain model year 2007 through 2011 Hyundai vehicles pursuant to Part 573 of Title 49 of the Code of Federal Regulations. Based on further discussions with Transport Canada, Hyundai has agreed to expand the recall in Canada to include additional vehicles. In the interest of consistency, Hyundai has decided also to recall the additional vehicles in the United States.

Dealers will be notified regarding the additional models and revised affected production ranges in October, 2013. The existing Technical Service Bulletin providing the recall service procedure will be updated to reflect the revised models and affected production ranges. Updated copies of these documents will be provided to NHTSA when available.
