

2. (a) The date notification to purchasers began: 3/25/13

(b) The date notification of purchasers was completed: On or about 6/31/13 with exception of 454 identified as having unusable address information for first class mailing.

4. (a) Total Number Inspected & Remedied: Three quarter cumulative of 15,234 Hook Guards provided/liners remedied per inclusion with the Part 577 customer notifications mailed. (See 573 notice for details of alternative remedies; (a.) installation of supplied Hook Guard or (b.) return of torn floor liners). Of the customers notified, 707 (cumulative- 52 this quarter) requested and were provided a new front Floor Liner with a Hook Guard installed. Additionally, Quadrtec® received 63 additional requests (8 this quarter) for Hook Guards only which were supplied to assumed users of the affected floor liners.)

Total number of items which were inspected and/or otherwise repaired or remedied.

(b) Total Number Inspected & NOT REQUIRING REMEDY: Per 577 notification, Quadrtec® recommended all customers inspect or use furnished Hook Guard to reinforce anchor area of suspect Floor Liners. Customers were given option of returning suspected torn liners for exchange. Among the 419 liners returned as of 7/15/13, Quadrtec® has inspected a cumulative total of 67 liners (1 this quarter) which appeared unturned.
