**1. Vehicles affected are manufactured by:**

Blue Bird Corporation  
P. O. Box 937  
Fort Valley, GA 31030

**2. The following vehicles are being recalled:**

Certain 2013 through 2015 model year Blue Bird Vision model non-school buses manufactured from December 05, 2011 through July 02, 2014 and equipped with optional Roush CleanTech propane fuel system.

**3. The total number of vehicles recalled potentially containing the defect are:**

**4. The approximate percentage of the total number of vehicles estimated to actually contain the defect is:**

Unknown

**5. The defect consists of:**

Due to engine to body relative motion on rough roads, the return fuel line can fatigue which could lead to a crack in the fuel line near a support bracket. This could result in a leak of the propane fuel, which could lead to a fire.

**6. The following data is the basis for the determination of the defect.**

On June 30, 2014 Blue Bird received notification from Roush CleanTech, that they had received a limited number of reports of propane fuel odor while in operation. Inspections revealed that the fuel return line could develop cracks near a welded support bracket.

On July 18, 2014 Blue Bird decided to declare a safety related recall to correct the defect on affected buses equipped with Roush CleanTech propane gas engines. To date, no reports of injuries, fatalities or fires related to this condition have been received.

**7. The defect will be corrected in the following manner:**

The existing fuel return line will be replaced and new fuel line support clamps will be installed.

**8. Notification will be as follows:**

The dealer notification letter is scheduled to be issued on or about August 14, 2014. The owner notification letter is scheduled to be issued on or about August 14, 2014.

Parts to remedy the defect are anticipated to be available at time of notification.

**9. Blue Bird's identification number assigned to this recall is:**

R14XJ

**10. Dealer and Owner Notification:**

A draft copy of the notification documents will be provided to NHTSA for review prior to mailing.
