**Problem Description:**

Spartan Motors USA (Spartan) is recalling certain model year 2017 Spartan Specialty Vehicle K2 and K3 vehicles manufactured March 24, 2016, to August 31, 2016. The throttle circuit wires on the affected vehicles may not have been twisted to cancel out electromagnetic interference, and as a result, interference may cause the throttle signal to be higher or lower than intended.

**Consequence:**

Unintended deceleration or acceleration can increase the risk of a crash.

**Remedy:**

Spartan will notify owners, and dealers will install an overlay harness with twisted wires, free of charge. The recall is expected to begin November 9, 2016. Owners may contact Spartan customer service at 1-800-543-5277. Spartan's number for this recall is 16025.

We have received Spartan's proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
