

All units have the same design and were manufactured using the same process.

III. Describe the Defect or Noncompliance

5. Describe the defect or noncompliance. The description should address the nature and physical location of the defect or noncompliance.

Illustrations should be provided as appropriate. Each of the Dorman steering knuckles that are the subject of this recall are made of aluminum. As of the filing of this report, we are investigating a report of only one failed unit. The exact cause of the failure is uncertain at this time but it is suspected that some or all of the units may have been made with improperly processed aluminum.

Describe the cause(s) of the defect or noncompliance condition. The exact cause of the failure is uncertain at this time but it is suspected that some or all of the units may have been made with improperly processed aluminum.

Describe the consequence(s) of the defect or noncompliance condition. A failed steering knuckle may cause the loss of steering control.

Identify any warning which can (a) precede or (b) occur. No audible or visual warning would precede the failure.

IV. Provide the Chronology in Determining the Defect/Noncompliance

February 2, 2009 – Dorman Products first became aware that a single steering knuckle. Investigation into the potential defect began and is ongoing.

February 3, 2009 – In an abundance of caution and prior to making any final determination that a safety defect may exist, Dorman Products ceased shipping all subject parts and began recalling all such parts identified in I(2) above from its customers inventory.

February 11, 2009 – Dorman Products determined that a defect in design or manufacture may exist and that a recall is warranted.

7. With respect to a noncompliance, identify and provide the test results or other data (in chronological order and including dates) on which the noncompliance was determined. Visual inspection of the single returned unit established that the unit had failed. Metallurgical test results are ongoing. Testing results will be provided as available.
